8. That the salary shall be/ is being paid to the staff members through bank/ accounts payee cheque/ through bank advice, as prescribed by NCTE.

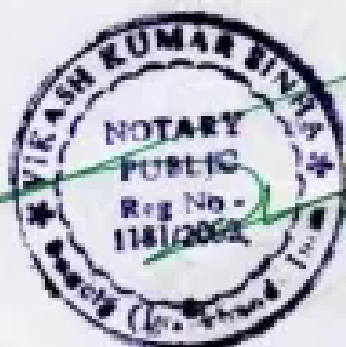
